Dr Maria Joao Branco is part of the team of Portuguese medievalists working on the project 'Fasti Ecclesiae Portugaliae', and is also currently working on a book on King Sancho I (1185-1211), which is due to appear in 2005. She is Assistant Professor of Medieval History in the Universidade Aberta, Lisbon, and was formerly Director of the Instituto Camões Centre for Portuguese Language University of Oxford, 2001-2003, and Visiting Research Fellow of St John's College, Oxford, during the same period. After earlier works on the fields of urban and rural history in the 15th century and ecclesiastical culture (1985-1989), she became interested in aspects of the new political history related to state building and the development of 'national identity' in Portugal, 12th-13th centuries. Her Ph.D. (1999) was on the influence of ecclesiastics in the theoretical and practical construction of royal power from 1179 to 1223.

Kathryne Beebe is a D.Phil. student at Pembroke College, Oxford. In 2002, she completed her M.St. on pilgrimage and spirituality in the *Book of Margery Kempe*. Her current research focuses on pilgrimage to the Holy Land, popular religion, and the latemedieval book trade. She is a co-convener of the Oxford Medieval Church and Culture Seminar and secretary of the Oxford Medieval Society.
