Laura Carlson

Having completed masters' degrees in medieval studies at both Oxford and the University of Toronto, Laura Carlson is currently in her first year of the D.Phil. programme in medieval history at Lady Margaret Hall. Her research interests focus predominantly on the early middle ages, specifically textual depictions of lay access to the divine. This includes the medieval inheritance of classical dream hierarchies, depictions of the afterlife, the evolution of the Christian prophetic tradition, as well as lay oneiric experience. At present, she is investigating the conceptualisation of vision from the sixth to the ninth centuries with particular emphasis on the theological distinction between ecclesiastical and lay sense of sight.
